**(i) Ebost ynghylch baeddu gan gŵn, a dderbyniwyd oddiwrth y Cyng Simon Roberts.**

Darlennodd y Clerc ebost a dderbyniwyd oddiwrth y Cyng Simon Roberts, yn sôn am Faeddu gan Gŵn ym Mhentref Llandybïe, ac roedd nifer o'r aelodau a oedd yn bresennol hefyd wedi cyfeirio at y fath broblem, a'u pryderon yn ei gylch.

Roedd yr ebost yn cyfeirio at broblemau iechyd cyhoeddus a'r niwsans a achosir gan Faeddu gan Gŵn, tra'n cynnig datrysiau addysgu'r cyhoedd, yn cynnwys cyhoeddusrwydd uniongyrchol, prosiectau ysgol a thrwy gyfrwng grwpiau lleol, ynghyd â drwy osod biniau newydd mewn ardaloedd sy'n peri consyrn.

Eglurodd y Clerc bod modd, yn gyffredinol, ystyried y fath bryderon ond rhaid cofio na allwn ychwanegu biniau mewn mannau lle nad ydym yn berchen ar yr ased, neu'r tir y mae wedi'i leoli arno. Mae hefyd yn ffaith y byddai'n rhaid i'r Cyngor ddarparu adnoddau i waghau'r biniau. Esboniodd bod y Cyngor Sir, mewn gwirionedd, wrthi'n rhesymoli'r ddarpariaeth biniau. Roedd yr Is-Gadeirydd, y Cyng J. Tandy, wedi cynnig cysylltu â Chyngor Tref Llandeilo gan eu bod wedi cynnal ymarfer ymgynghorol ynghylch y fath fater.

Roedd y Cyng C. R. Thomas o'r farn y dylid hysbysebu'r bygythiad i iechyd ym mhapur y South Wales Guardian ac mewn cyfryngau eraill. Roedd y Cyng N. C. Davies yn cytuno, ond o'r farn bod hefyd yn bwysig darparu ffyrdd o waredu ar y 'Bagiau Baw Cŵn' hefyd yn bwysig. Roedd hefyd wedi gwneud cais ein bod gosod biniau ger y mynedfeydd i lwybrau troed sy'n arwain at briffyrrdd ac ardaloedd preswyl. Roedd y Cyng Thomas hefyd yn teimlo bod sbwriel arall yn cael ei osod yn y biniau baw cŵn.

Dyweddodd y Cyng D. Thomas nad oedd y nifer o finiau ym Mhenygroes wedi gostwng, ond ei fod, serch hynny, wedi derbyn llawer cwyn. Roedd hefyd wedi cynnig syniadau er mwyn datrys y broblem.

Roedd y Cyng A. W. Jones o'r farn bod pob ardal yn wynebu problemau, a dylid ystyried cydweithio gyda Chyngorau Cymuned eraill, a gosod hysbyseb yn y wasg

leol. Roedd hefyd o'r farn y dylai'r cyngor frwydro yn erbyn y Cyngor Sir er mwyn derbyn rhagor o finiau.

Dyweddodd y Cyng K. D. L. Davies bod Ward Saron Ward wedi colli ond un bin, tra bod y Cyng A. J. Evans o'r farn bod papurach cludfwyd hefyd yn broblem, ond y byddai gwell gwyliadwraeth gan Wardeniaid Cŵn efallai yn gallu bod yn ddatrysiaid.

**(a) Parciau:**

**(i) Saron a Chapel Hendre, Adran 106. Yn dal ar y restr i'w ddilyn i fyny gyda Chyngor Sir Caerfyrddin.**

Ni dderbyniwyd unrhyw ddiweddarriad pellach yngylch y ddua swm, sef £22,320.00 ar gyfer darpariaeth addysg at y dyfodol yn Saron, a £17,680.00 ar gyfer Parc Cwmgwili. Mae'r Clerc yn pwysu ar y Cyngor Sir am ymateb.

**(ii) Difrod i offer chwarae ym Mharc Llandybïe:**

Bydd y Clerc yn adrodd yn ôl yngylch y digwyddiad ar y Trampolin a gofnodwyd gan yr Heddlu, a sy'n cwympo o fewn termau'r gwarant a dderbyniwyd gan y contractwr a osododd yr offer yn ei le.

**(b) Llwybrau Troed. Nid oes unrhyw ddiweddarriadau pellach yngylch y Llwybrau Troed isod.**

Mae'r Clerc a'r Swyddog Gweinyddol yn dal i bwysu ar dîm y Cyngor Sir yngylch y llwybrau troed canlynol ac yn bwriadu cadw'r rhain yn Adroddiad y Clerc tan eu bod wedi'u datrys.

- Penygroes 51/34 a 51/33;** mae'r Clerc yn dal i geisio mynnu diweddarriad oddiwrth y Cyngor Sir. Mae 51/33 yn cynnwys cael y tirfeddianwr i dorri'r canghennau sy'n bargodi dros y llwybr. Mae'r Clerc wedi dweud bod gennym hawl i gyfarwyddo'n Contractwr Llwybrau Cerdoded i dorri'r canghennau sy'n bargodi'n uniongyrchol dros y llwybr.

- **51/51;** Mae tîm cyfreithiol Cyngor Sir Caerfyrddin yn dal i ddelio â hyn oherwydd bod preswylydd wedi adeiladu sail i garej ar draws yr hawl tramwy cyhoeddus, ac mae preswylydd arall wedi gosod offer chwarae drosto. Bydd y Clerk yn diweddarur cynghorwyr yn y cyfarfod.
- **51/106;** Erbyn hyn mae'r llwybr troed hwn yn cael ei ail-agor wedi esgeulusdod a difrod storm, ac mae'r Cyngor Sir wedi gosod gât newydd yn ei lle ger ymyl yr ardal goedig dan sylw.
- **51/13;** Cofnodwyd hwn gan y Cyng D. Thomas a bydd yn cael ei archwilio yn ystod yr wythnos sy'n dod.

**(c) Prosiect Parc Banc Y Ddraenen;**

Diweddariad: This project is now actioned and will be undertaken over the coming months.

- The Hedge line along the length of the park along to the main road with two planting benches had now been agreed to be installed by Carmarthenshire County Council at no cost to our budget week beginning 27<sup>th</sup> of January.
- The wildlife and nature reserve area has taken a step forward with an Ecology Report completed in conjunction with the council's planning dept. This will be discussed the next Environment Committee.
- The Bird Box and Schools project was in hand and would be carried out in the coming months once the work on the nature reserve is realised in more detail.
- The two Apple Trees that failed to root are being replaced at no cost in early spring by the County Council.
- The Clerk has not yet looked the 'Vision Sign' for the park to inform residents, as the project is current ever changing with the nature reserve due to be confirmed.
- The concrete post and chain mail fence that was getting unsafe was removed earlier this month. This has opened up the area.
- The Clerk is also working with the council on managing the meadow and scrub areas with sympathetic cutting and planting schemes, this is being discussed within the 2025/26 cutting regime.
- Basically the only undeveloped area not yet decided on is the old hard surface foundation of the demolished Capel Hendre Hall. This will further be discussed at the Environment Committee.

**(e) Llandybie Tennis Courts;**

Work is now set to start in late February on the new surface, site visits by the successful contractor South Wales Sport Grounds having taken place and site-specific Risk Assessment & Method Statements along with the Site set up and Traffic Management Plan has now been received and is being reviewed by the Clerk in conjunction with the Memorial Hall to ensure no disruption to the hall and post office business.

The contractor is happy to invoice on completion of the project in late March and for the invoice to be paid out of the new budget in April, upon which time the Clerk will draw down £15,000 from the successful application from the Betws Wind Farm Fund.

**Discussion;**

Y Cyng R. A. Davies drew attention to a draft proposal that the Memorial Hall had received from the Clerk regarding access to undertake the project and felt it was unsatisfactory on a few points including proximity to the Children's Play area, Y Cyng A. W. Jones joined the discussion saying that the Memorial Hall had shared the proposal with him and he had many concerns.

The Clerk explained that he was disappointed in the Memorial Hall for sharing the report and that it was in fact a draft for discussion prepared by the contractor as a starting point to put a formal plan in place, the plan he explained had already been rejected by him on Monday when he received it, a fact that had already informed both councillors of in an email, and in the case of Y Cyng R. A. Davies in a phone call on Monday morning. He also explained that Ordinary Meetings were not the place to discuss early draft plans which were still in discussion with partners of the project and further, he did not understand why the Memorial Hall would have shared the information in the first place.

Y Cyng R. A. Davies once again raised his concerns about the storage area on the car park next to the Children's Play Area, the Clerk again explained he had already informed him this had been reject on Monday as he had just explained in the opening explanation of the item.

V. Chair Y Cyng J. Tandy intervened and felt it was not a productive use of meeting time discussing something that was an ongoing draft and in the case of the storage area was not going to happen.

The Chair agreed that the Clerk continue with his report.

**(f) Heating System at Bowls and Tennis Pavilion;**

The Clerk has now met three specialist local contractors onsite who have surveyed the building and have quoted on the work with one quote left to be received, all three contractors have confirmed that we are eligible for a Green Voucher Grant of £7,500 towards the cost. The Clerk will further apply for to the Betws Wind Farm Fund for circa £8,000 to match fund our budget allocated of the £26,000 budget figure allocated.

The Clerk will meet with the Bowls and Tennis Clubs to explain the project and to try and tie in with the playing seasons.

**(g) Community Grants Update;**

We have now received circa 23 grant applications for consideration at our February Finance Committee thanks to the Administrative Officer putting reminder emails, letters and making phone calls.

**(h) Caerbrynn Community £20k contribution from reserves;**

The Clerk has now informed that the completion of the children's play area is now imminent and they will be requested the earmarked funds from our reserves to be paid. The Clerk on agreement of tonight's meeting pay the amount once a letter with bank details have been received.
